# Ashburn Farm Assessments & General Information

### **Collection Policy**

Assessments are due the first day of each month. Any installment of the annual assessment not paid to the Association within thirty (30) days after the due date shall be considered delinquent and a late charge of \$25.00 shall be assessed to the Owner and posted to the Owner's account every thirty (30) days delinquent.

#### **Home Sales**

Effective July 1, 1989, the Virginia General Assembly enacted a new law entitled the "Virginia Property Owner's Association Act". This act required the seller of a home to make certain disclosures to the intended purchaser of their lot. All home sales in Ashburn Farm are subject to the Virginia Property Owner's Association Act. A written request of the Association Disclosure Package and a check in the amount of: \$225.00 for an electronic disclosure (via email) for townhome/single family; \$250.00 for a paper disclosure for townhome/single family; \$100.00 for electronic or paper disclosure for condo; are required to begin processing. A rush fee of \$50.00 may be paid to receive your disclosure within 3 days. Checks should be made payable to the Ashburn Farm Association. A form is available on the website or at the Association office. The completed package will be issued within 14 calendar days to the requesting party or agent. For further information, please contact the Association office.

## **Board Briefs**



A complete draft of the Board Meeting Minutes will be reviewed and approved at the next Board Meeting, which are held the first Tuesday of each month. A

The following Meeting was held on June 8, 2021. President, Dave Tighe, called the meeting to order at 7:00 PM.

### The Board Members provided the following comments:

- Mr. Batchelder the fireworks were great. Talked with some members who wish they had been delayed as they wanted to have picnics. His wife has been doing and pulled together a team; they have taken a quick survey relative to a dog park. She would like to have time at the next Board meeting to present her findings, a full explanation and design.
- Mr. Hancock would like to look at and talk about organization maturity. Wants to consider doing a Six Sigma from the top down and bottom up to ensure that members are being served and work is being done efficiently.
- Mr. Fedak the fireworks were great; everyone he chatted with on the way out had positive things to say.
- Mr. Tighe thanked Jeremy and the Maintenance Staff on the work done and being done at 21111 Deep Furrow Court.

### **APPROVAL OF MINUTES**

Mr. Tighe asked for a motion to approve the May 4th, 2021, version 1.1 meeting minutes as submitted. Mr. Hancock made the motion to approve the minutes; Mr. Oakley seconded the motion. The motion passed (5/0/0/2) (Dr. Lubore and Mr. Brewer absent).

**PUBLIC FORUM** – nothing to report.

### APPEALS TO THE BOARD

- 20665 Perennial Lane, Appeal of Fence Location Denial

   No Board action; application was approved by the
   Architectural Review Board prior to the Board Meeting.
- 43188 Gatwick Square, Parking Space Reassignment –
   Ms. Karen Long addressed the Board stating proximity
   to a parking spot was a primary concern in her home
   purchase. There was discussion between the Board
   and the members present about how the issue
   came before the Board, the reassignment decision
   came about, and the research into how the original

assignment was made. President Tighe clarified that Ms. Long's comments were heard and since there was no dissent from the Board members about the previous vote by the Board, the decision stands.

### **MANAGER'S REPORT** – reported by Mr. Cushman.

- Trash Service Cost Increase Mr. Cushman spoke about the ongoing conversation with Patriot Disposal. He has requested they provide in writing that the fuel surcharge has been removed. Landfill costs account for much of the increase that has been passed along; it will go up next year as well. Customer service is an ongoing issue. There was discussion of how the increases affect members on a per home, per month basis, how to fund the increase and budgeting for other items. Concerns were raised about loose debris escaping from cans serviced by trucks with electric arms.
- Association Website status provided on data that
  is up and in progress of being verified, links checked,
  acronyms removed, etc. Discussion among Board
  about the feel and look of the new site. Action ItemMr. Cushman to provide estimated completion date.
- Proposed Cell Tower at Stonebridge High School

   discussion about a potential income stream for
   Ashburn Farm; who is proposing the cell tower. Action
   Item Mr. Cushman to reach out to see who is proposing and if there is a spot in Ashburn Farm to locate a tower.
- Management Software Update Mr. Cushman
   provided an update relative to the cost difference and
   stated that Summit has offered to split that cost and
   reduce cost of Vanteca on their side, if we will come
   up halfway, which would put us on a one-to-one with
   Summit and provide more real time information, a
   portal for the members and the financial information.
   Mr. Cushman proposed bringing the issue back to the
   Board in September. There was further discussion
   among the Board members.
- Draft 2022 Operating Budget & Reserve Study
   Update Mr. Cushman provided a very rough draft
   budget and stated there is a \$23,000 shortfall; the
   Reserve Study contribution assumes amount is going
   up approximately 1.73% year after year. There was
   discussion about interest on bonds and the inflation
   rate. Further discussion regarding assessments.
- Tennis Court Maintenance Mr. Cushman reported he did not think we should do this year. Summerwood

# Ashburn Farm Guest Pass Information

- Pool members are responsible for the conduct of their guests.
- Guest passes cannot be used for Ashburn Farm members.
- Pool members between the ages of 12 to 17 years may bring up to two guests to the pools.
- Each adult (18 and older) is limited to bringing five guests.
- Each guest age two and older must use a guest pass.
- Guests need to be accompanied by a pool member or have the member's pass with them when entering the pool.

- The four free Ashburn Farm member guest passes were electronically added to each household.
- Guest passes can be purchased for \$5.00 each at the pool; they accept checks only.
- Guest passes may be pre-ordered and purchased at a discounted rate by visiting the Association Office.
   Cash or check is accepted. Please see prices below.
- Guest passes are nontransferable or refundable, even in cases of bad weather.
- Paper guest passes do not expire.

# Pool Pass Application and Updates

The Association office processes requests for new and updated pool passes either through e-mail or in person. The office is open Monday through Friday and will process in-person pool pass applications until 4:00 p.m.

The pools will open this year and have a reservation process similar to last year's pool utilization. Be on the lookout for information about the reservation process, through Omnify, in the upcoming newsletters and e-mail notifications.

If requesting new or updating existing pool passes via e-mail, the request should be sent to pools@afhoa. net. Pictures should also be sent to the pools@afhoa. net e-mail. Please remember to include the name and address of each person.

### Steps requesting new pool passes:

### New residents will require the following:

- Pool pass application form.
- Proof of residency in the form of an ID or driver's license with the Ashburn Farm address. If the address has not been updated, a major bill must be submitted with the identification card. (electric, water, vehicle registration, etc.)
- Pictures in .jpg format for all residents over the age of nine in passport style, against a wall, from the shoulders up (see example below).
- Payment in the form of cash or check is accepted.
   The cost for each pass \$5.00. Checks should be made payable to Ashburn Farm Association or AFA.

### New tenants will require the following:

- Off-Site Member Contact form, filled out by both the homeowner and tenant. If one has not been previously submitted.
- Pool pass application form.
- Proof of residency in the form of an ID or driver's license with the Ashburn address. If the address has not been updated, a major bill can be submitted with the identification card. (electric, water, vehicle registration, etc.)
- Submit pictures in .jpg format for all residents over the age of nine in passport style, against a wall, from the shoulders up (see example below).
- Payment in the form of cash or check is accepted.
   The cost for each pass \$5.00. Checks should be made payable to Ashburn Farm Association or AFA.

# Summertime Grilling Safety Tips

Every year, 7,000 Americans are injured while using backyard barbecue grills. It's often a case of good products used incorrectly or in need of routine cleaning or maintenance. Whether using gas, wood, or charcoal briquettes, here are some common-sense Do's and Don'ts to keep in mind as you plan your next backyard barbecue...

### DO:

1. Keep your grill at least 10 feet away from your house. Farther is even

better. This includes portions attached to your house like carports, garages and porches. Grills should not be used underneath wooden overhangs either, as the fire could flare up into the structure above. This applies to both charcoal and gas grills.

- 2. Clean your grill regularly. If you allow grease and fat to build up on your grill, they provide more fuel for a fire. Grease is a major source of flare ups.
- 3. Check for gas leaks. You can make sure no gas is leaking from your gas grill by making a solution of half liquid dish soap and half water and rubbing it on the hoses and connections. Then, turn the gas on (with the grill lid open.) If the soap forms large bubbles, that's a sign that the hoses have tiny holes or that the connections are not tight enough.
- 4. Keep decorations away from your grill. Decorations like hanging baskets, pillows and umbrellas look pretty AND provide fuel for a fire. To make matters worse, today's decor is mostly made of artificial fibers that burn fast and hot, making this tip even more important.
- 5. Keep a spray bottle of water handy. That way, if you have a minor flare-up, you can spray it with the water to instantly calm it. The bonus of this tip is that water won't harm your food, so dinner won't be ruined!
- 6. Keep a fire extinguisher within a couple steps of your grill. And KNOW HOW TO USE IT. If you are unsure how to use the extinguisher, don't waste time fiddling with it before calling 911. Firefighters say many fire deaths occur when people try to fight a fire themselves instead of calling for expert help and letting the fire department do its job.

### DON'T:

7. Turn on the gas while your grill lid is closed. NEVER do this. It causes gas to build up inside your grill,

- and when you do light it and open it, a fireball can explode in your face.
- 8. Leave a grill unattended. Fires double in size every minute. Plan ahead so that all of your other food prep chores are done and you can focus on grilling. Better yet, appoint a grill master ahead of time to handle this task.
- 9. Overload your grill with food. This applies especially to fatty meats. The basic reason for this tip is that if too much fat drips on the flames at once, it can cause a large flare-up that could light nearby things on fire.
- 10. Use a grill indoors. People often think it will be safe to use a grill, especially a small one, indoors. NOT TRUE. In addition to the fire hazard, grills release carbon dioxide, the deadly colorless, odorless gas. That gas needs to vent in fresh air or it can kill you, your family and pets.

# Loudoun County Route 7 Corridor Study

This draft corridor study examined existing and projected future conditions along Route 7 in Loudoun County, Virginia, between the Route 28 interchange and Dranesville Road (Route 228) at the Fairfax County line, approximately 4.25 miles.

A corridor study is a planning project that defines the relationships between a roadway and its adjacent land. Corridor studies are used to:

- Define acceptable levels of access and mobility,
- Determine transportation system needs to support surrounding land uses,
- Consolidate and control access points,
- Identify operational deficiencies and promote operational efficiency, and
- Promote redevelopment of an underperforming corridor.

Corridor studies evaluate conditions for a projected design horizon, usually approximately 20 years into the future. For this study, the Design Year of 2040 was selected as this study was initiated in 2020. The public

# Lawn Watering Guide: Tips and Tricks

### Don't Overdo It

It's easy to either assume that your lawn will get the water it needs from the rain or that occasionally drenching the soil will give your grass all the water it needs – but it doesn't work like that!

A lawn irrigation system, whether that's a timed schedule on your behalf or a sprinkler system, must be in place to ensure your lawn can grow healthily, particularly during the growing season.

So, whether you're watering grass seed, or you intend to irrigate a lawn already in your yard, remember not to drench the soil with too much water. This technique may result in disease growth, including fungus, which damages the health of your grass. It also compacts the soil, which makes it harder for roots to absorb the nutrients they need from the soil.

A good rule of thumb is to ensure that your lawn gets between an inch and 1.5 inches of water every week. Prepare a Schedule

Knowing the best time to water a lawn is key to encouraging healthy new grass growth.

For new grass seed watering, be sure to stick to these rules:

- Water once per day for two to three days before you plant any new seed.
- Once a new seed is planted, water the lawn again for roughly 10 minutes.
- Until you see the seeds sprouting, water your lawn morning and night for ten minutes each time.
- Once the grass has begun to sprout, return to a normal watering schedule – meaning 1-1.5 inches of water per week.

In terms of the best time to water grass, we say it's the morning.

Watering a lawn during the cool temperatures of the morning, before 9 am, reduces the amount of water that evaporates from the surface of the soil before it can sink into the ground and feed the roots.

This not only ensures that our lawn is getting the right amount of water but also saves you money on your water costs.

### How Long to Water a Lawn

When you're watering grass seed or lawns, it might help to know how long to water your lawn. We've already talked about how the average lawn needs between 1 and 1.5 inches of water per week, but that might be hard to visualize.

If you're aiming for an inch of water, be sure to water the lawn for 20 minutes roughly three times per week. You can

do this more thoroughly and accurately with a sprinkler system, but you can, of course, do it yourself with a hose. If you're aiming for one and a half inches, then the best way to water your lawn is to aim for 30 minutes three times per week.

If you live in an area with extreme heat or sunshine, you might want to increase that number – or simply remember our trick of watering the lawn between 4 am and 9 am. That way, you reduce the risk of your water evaporating in the sun.

### Is Your Grass Watered Enough?

As we've discussed, watering new grass and lawns requires getting the volume of water and frequency of watering right – but how do you know if your grass is watered enough?

Here are the most noticeable signs that your lawn isn't watered enough:

- Dry soil
- · Slow new growth
- Footprints in the grass
- And some signs that you're watering your lawn too much:
- Too much thatch (or dead organic material) in the lawn
- Fungus
- Weeds

# Keep Lawn Type in Mind Newly Seeded Lawns

Watering a new lawn requires the top layer – roughly one inch – of soil to be moist at all times. Remember to mist the lawn once or twice every day, and once the seeds start germinating, continue watering daily.

### **Cool-Season Grass**

Tall fescue cool-season grass has the highest tolerance to drought out of all kinds of grass, meaning it can be watered less. However, fine fescues, perennial ryegrass, and Kentucky bluegrass will go dormant if they aren't watered. They will be revived once watered again.

### Warm-Season Grass

Warm-season grass generally requires less water than coolseason grass, so you'll need to decide how to water a lawn based on your weather – specifically, how much rainfall you experience during the summer.

**WHEREAS,** Ashburn Farm Association (the "Association") is a Virginia nonstock corporation and subject to the provisions of the Virginia Nonstock Corporation Act; and,

**WHEREAS,** <u>Article III, Section 3, Subparagraph (b)</u> of the Covenants of the Association invests the Board of Trustees with all powers for the conduct of the affairs of the Association which are enabled by law, the Declaration and the articles of Incorporation which are not specifically reserved to the Members.

**Now Therefore, be it Resolved** that the Ashburn Farm Association hereby establishes the following procedures to facilitate Virtual Meetings, Electronic Voting, & Electronic Communication of the Board of Trustees, Architectural Review Board, and all Committees established by the Board of Trustees and to permit members of the aforementioned bodies to participate in, and vote on business before the respective body remotely.

Procedures for Electronic Meeting and Attendance by Members Remotely

- 1. Circumstance permitting Electronic Meetings and/or Remote Participation by Members. Electronic meetings of the Ashburn Farm Association Board of Trustees, Architectural Review Board, or Board of Trustees Appointed Committees in whole, or in part, and/or attendance by members of those bodies, or of the community remotely are permissible under the following conditions:
  - Before July 1, 2021, any Member with a medical condition, military service, or as the result of a statewide emergency declaration.
  - After July 1, 2021, for any circumstance.

### 2. Meetings Held Electronically

 Communication – The Association will use an internet-based video and audio service to provide 2-way communication so that Members attending the Meeting can both hear other members and speak to those members, as well as facilitating similar

participation from the community. To accommodate those that may be having difficulty addressing the body, comments may be provided to the body prior to the meeting, or those questions can be submitted via email or through the video meeting service.

- Notice Any meeting to be held electronically shall be preceded by a notice of at least three days unless otherwise required by the State of Virginia, or the Bylaws of the Association such as a Meeting of the Members. Furthermore, the notice shall include contact information for the Association to that members of the community may provide input or ask questions regarding business that will come before the body.
- Agenda If an agenda exists for the meeting, then the agenda will be made available
  for that meeting at least three days before the meeting begins by publishing the
  agenda to the community member's email addresses provided for such purpose
  and/or posting the agenda on the Association Website.
- Identifying Members that Wish to Provide Comment Community Members do not have to preregister with the Association to participate in the meeting but may be required to identify themselves, or provide other information such as a street address, to participate in the public comment portion of the meeting.
- Physical Presence Physical presence is not required to participate in or vote on a matter before the body given that member can attend remotely.

### 3. Remote Participation by Member(s) of the Board or Committee

- Communication The Association will use an internet-based video and audio service
  to provide 2-way communication so that Members attending the Meeting can both
  hear other members and speak to those members, as well as facilitating similar
  participation from the community. Each Member attending remotely must
  announce that they are attending remotely and announce their physical location, by
  stating the state & county they are in while attending the meeting. To accommodate
  those that may be having difficulty addressing the body, comments may be provided
  to the body prior to the meeting, or those questions can be submitted via email or
  through the video meeting service.
- Notice Any meeting to be held electronically shall be preceded by a notice of at least three days unless otherwise required by the State of Virginia, or the Bylaws of the Association such as a Meeting of the Members. Furthermore, the notice shall include contact information for the Association to that members of the community may provide input or ask questions regarding business that will come before the body.

The Board of Trustees adopted this Resolution at a duly convened meeting on <u>June 8, 2021</u> and directed that the same be incorporated in the Book of Resolutions.



# LEx Reporting System for Non-Homeowners Association Related Concerns

The Association Office receives many concerns from homeowners throughout the year and we are happy to help address those concerns whenever possible. Unfortunately, when a concern is for an issue that is not covered by the Covenants or Architectural Standards, we try our best to refer homeowners to the appropriate Agency or Group that are better suited to help.

One option can be found on the Loudoun County website called the Loudoun Express Request System or LEx at: https://www.loudoun.gov/3055/Report-an-Issue. It is a citizen request system for members of the public to submit requests for service and report concerns to the county government via the internet and a mobile application.

The LEx platform provides an option for users to follow and receive updates on some requests that have been entered by a fellow community member. On these public requests, the username of the original submitter is visible by fellow community members and a pin with the relevant information appears on the LEx map. Users always have the option to switch these requests from public to private using the toggle at the bottom of the request form.

The LEx platform not only deals with concerns, but other common issues and questions as well. Some of those categories include:

- Animal Complaints and Barking Dogs
- Towing complaints from VDOT roads
- Suspected Hoarding
- Overcrowding Too many people living in a single-family dwelling
- Permits building, signs and zoning
- Environmental Health human health related to water, air and land issues
- Pests/Insects Advisement on Infestations or Health Concerns
- County owned roads and Transportation
- Utilities and Public Infrastructure
- Unregistered or Non-Compliant Vehicles on VDOT roads
- Constituent and Business Services when you're not sure who to notify in the County or for small business assistance
- Staffed and Unstaffed Park Maintenance Issues
- Bicycle and Pedestrian Facilities
- Roadway Planning
- Rideshare and Vanpool Opportunities


