The Board of Trustees is an all-volunteer resident group that is responsible for interpreting the covenants and rules governing Ashburn Farm. Board of Trustees meetings are held on the first Tuesday of every month at 7:00 p.m. at the Windmill Community Center located on Windmill Drive. All Ashburn Farm homeowners are encouraged to attend.

Ashburn Farm Assessments & General Information

Collection Policy

Assessments are due the first day of each month. Any installment of the annual assessment not paid to the Association within thirty (30) days after the due date shall be considered delinquent and a late charge of \$25.00 shall be assessed to the Owner and posted to the Owner's account every thirty (30) days delinquent.

Home Sales

Effective July 1, 1989, the Virginia General Assembly enacted a new law entitles the "Virginia Property Owner's Association Act". This act required the seller of a home to make certain disclosures to the intended purchaser of their lot. All home sales in Ashburn Farm are subject to the Virginia Property Owner's Association Act. A written request of the Association Disclosure Package and a check in the amount of: \$225.00 for an electronic disclosure (via email) for townhome/single family; \$250.00 for a paper disclosure for townhome/single family; \$100.00 for electronic or paper disclosure for condo; are required to begin processing. A rush fee of \$50.00 may be paid to receive your disclosure within 3 days. Checks should be made payable to the Ashburn Farm Association. A form is available on the website or at the Association office. The completed package will be issued within 14 calendar days to the requesting party or agent. For further information, please contact the Association office.

BOARD BRIEFS

A complete draft of the Board Meeting Minutes will be reviewed and approved at the next Board Meeting, which are held the first Tuesday of each month. A complete set of minutes is available on the Association's website, Board of Trustees page: https://ashburnfarmassociation.org/board-of-trustees/.

The following Meeting was held on January 4, 2022. Vice President, Scott Batchelder, called the meeting to order at 7:00 PM.

APPROVAL OF MINUTES

Motion to approve the December 7th Board meeting minutes as submitted passed, (5/0/0/2), Mr. Tighe and Dr. Lubore absent.

BOARD MEMBER COMMENTS

Mr. Fedak – Extended a Happy New Year to all and stated that he enjoyed the holiday contests we held.

Mr. Hancock – Extended a thank you to the community and the staff for the acknowledgement and volunteer appreciation gifts. He revisited the Six Sigma process methodology that was discussed at previous meetings and expressed the need for BOT buy-in and BOT participation to move forward.

Mr. Brewer – Echoed the sentiments regarding the volunteer recognition and thank you to volunteers. He acknowledged Mr. Cushman for his quick action and adaptability regarding Covid control/safety measures.

Mr. Oakley – Thanked Mr. Cushman and association staff for volunteer acknowledgement. He also expressed appreciation for the exceptional handling of the snow removal

Mr. Batchelder – Extended "Get Well" wishes to Mr. Tighe. He shared his copy of the "Across the Fence" community newsletter and stated he thought it was the best one ever. He especially enjoyed the photos of work around the community and the new design layout.

PUBLIC FORUM -

Mrs. Kimberly Fortney spoke about trash and expressed a need for alternative solutions, especially in the event of suspension of service occurrences. Mr. Fedak added comments about the newly formed Townhome Neighborhood Committee.

MANAGER'S REPORT — reported by Mr. Cushman

Annual Inspection Notices, Process,

Communication – Mr. Cushman stated that the plan is to use the same processes for 2022 annual property inspections as was used in 2021 with the exception that property owners will receive a copy of their completed inspection report unless it is a Priority One, in which case appropriate violation/enforcement communications will be sent to enforce Association standards. Action

Item – Mr. Cushman to coordinate with Mr. Hancock on the webpage Notification and Postcard, discussion planned for February Board Meeting. Action Item – Mr. Hancock to review all property inspection related documents and revise as needed. Documents to be available prior to February Board Meeting.

Townhome Neighborhood Committee – Mr. Cushman introduced Mr. Bobby Butler as the committee's nomination for Chairperson. Mr. Butler gave a brief synopsis of his leadership qualifications and shared that he and his family moved to Ashburn Farm in 2009. The motion to approve Bobby Butler as Chairperson of the Townhome Neighborhood Committee passed, (7/0/0/0). There was no discussion, but Mr. Fedak commented that it was a good meeting, that Mr. Butler came well prepared, and there was a lot of good discussion; people were able to air problems and grievances.

Mr. Hancock asked if the Board wanted to move forward with approval of the Townhome Committee Charter. Action Item: Mr. Cushman to place the Townhome Committee Charter on agenda for February Board Meeting.

Solar Panel Installation Update – Mr. Cushman stated that the interconnection application has been sent to Dominion Power; is awaiting approval. Once the interconnection for all locations is approved, work to begin panel installations will be scheduled. Removal and replacement of the asphalt portion of the Breezyhill Pool bathhouse roof was completed.

Directors & Officers Insurance Renewal - Mr. Cushman stated our current carrier is no longer writing these policies, so he is seeking quotes from new carriers. Action Item: Mr. Cushman to present policy quotes for Board review at the February meeting.

Swimming Pool Usage Agreements – Mr. Cushman stated the hourly cost to operate the pools has increased; staff recommends increasing the pool rental rate for swim teams. Action Item: Mr. Cushman to put pricing together for February Board Meeting.

Architectural Review Board Meeting Minutes – Mr. Batchelder stated that things are going well, and he is looking forward to applications going all online. Mr. Batchelder commented that when homeowners attend meetings virtually and can clarify and respond directly to questions it streamlines the process.

Budget & Finance Meeting Minutes, Bank Balances & Financials – Dr. Lubore reported that funds that would not be immediately needed were moved from cash accounts to bond investment accounts. **Action Item: Dr. Lubore to forward the spreadsheet with the breakdown to the BOT.**

NEW BUSINESS

Association 2022 Event Planning – Mr. Cushman provided a framework for events that can be safely held during 2022 either as ongoing (Beautification Day), one-time family/community (Summer Kick Off, Middle School Swim Night, and K9 Kool Off), or other sponsored events. A suggestion to reevaluate events and move funding to pay for safety upgrades at the Summer Kick Off. Action Item – Mr. Cushman to provide safety upgrade related costs.

2022 Non-Resident Pool Membership Consideration – Motion to approve the opening of the community pools to outside membership for the 2022 Season at a cost of \$425 for family membership; \$200 for individuals passed, (7/0/0/0).

2022 Above-Ground Pool Consideration – Motion to refer the Above-Ground Pool policy to the Architectural Review Board for review passed; (6/1/0/0), Mr. Tighe opposed.

Annual Meeting Date of Record – Mr. Cushman presented information and proposed date, time, and location for the Annual Meeting of the Membership. **Tabled** – **no action taken.**

INFORMATIONAL

Association Delinquent Status Report – There were no actions to be taken.

Motion to move to Executive Session to discuss pending litigation passed, (7/0/0/0).

EXECUTIVE SESSION – There were no actions to be taken.

Return from Executive Session at 8:41PM.

ADJOURNMENT

Motion to adjourn passed (7/0/0/0). Adjourned at 8:50PM.

The Association is responsible for snow removal on townhome neighborhood streets.

The Ashburn Farm Association is not responsible for pretreating or snow removal on any state or county-maintained roadways. Recreation areas, trails, and parking lots will be cleared on an as-needed basis, at the discretion of the Association.

- Snow removal will start after two inches (2") of snow has accumulated on paved surfaces, a ¼ inch of ice has accumulated on paved surfaces, or at the discretion of the Association.
- All single-family homes are located on state or county (VDOT & Loudoun County) owned streets; snow removal on those streets is the responsibility of VDOT / Loudoun County. To contact VDOT please call 703-383-VDOT (8368).
- Please allow 18 hours for every 6" of snow accumulation for the roads to be cleared. If you're essential personnel or are required to be available for work around the clock, please make private arrangements or park on a VDOT street.
- Ice melt will be applied at the discretion of the Association and the conditions in each neighborhood. Unsafe conditions should be reported to the Association immediately.
- Ice melt application trucks will patrol Association owned streets after a snow or ice event, and after a melt/ freeze cycle (warm day/freezing night) immediately following the snow or ice event at the discretion of the management. Please use caution when traveling after a melt/freeze cycle and ensure that appropriate footwear and driving practices are chosen to best deal with the conditions present at the time.
- All snow removal equipment contracted by the Association must maintain a minimum of thirty-six inches (36") of clearance from all parking spaces. The snow that accumulates within the thirty-six inches (36") is the sole responsibility of the person(s) assigned to or using the parking space. Curbside and open parking spaces will not be cleared.
- Vehicles parked curbside in the townhome areas must be moved to allow for snow removal. Failure to do so will result in a less efficient snow removal process and parked vehicles could become stuck due to snow deflecting off plows. Owners that find themselves in this situation due to an unmoved car will be responsible for clearing these areas. Vehicles parked in violation of the Association's Tow-

Without-Notice policy will be towed.

- Please do not clear snow from driveway entrances or vehicles and place in/on the street, thinking a plow can/will remove it. Once a street has been cleared, plows will not return to the street. Callbacks due to disposing of snow on Association streets may be charged to the responsible party.
- Please remember that when clearing snow from a driveway, parking space, etc. prior to the street or parking lot plowing by the snow removal contractor; snow may be unintentionally deflected by removal equipment during plowing and may come to rest in driveways or parking spaces. In cases such as these, neither the Association, nor the snow removal contractor are responsible for clearing deflected snow. It is the responsibility of the resident to clear this snow.
- Snow should never be deposited onto streets, sidewalks, parking spaces. If shoveling or blowing snow, deposit it onto your own property or grass covered common areas. This applies to contractors, residents, or anyone hired to perform snow removal service by a resident. The Association is not responsible for removal of snow piled in the street, in a parking space, or on the sidewalk by residents or a contractor hired by residents; however, should the Association be forced to remove it, the responsible party will be charged.
- Snow will be removed from Association owned mailboxes in the townhome areas by the snow removal contractors to allow mail delivery. Please use caution when retrieving mail.
- The Ashburn Farm Association is not responsible for removing the snow from sidewalks abutting private property, such as in front of townhomes or single-family homes. Removing snow and ice from County and VDOT sidewalks abutting one's own property is the sole responsibility of the homeowner.
- Sidewalks and trails will be cleared when snow accumulation of two inches or more has occurred, or at the discretion of the Association. The application of ice melt will be minimal on these areas. Please use caution and ensure footwear is suitable for the conditions.


