The Board of Trustees is an all-volunteer resident group that is responsible for interpreting the covenants and rules governing Ashburn Farm. Board of Trustees meetings are held on the first Tuesday of every month at 7:00 p.m. at the Windmill Community Center located on Windmill Drive. All Ashburn Farm homeowners are encouraged to attend.

Ashburn Farm Assessments & General Information

Collection Policy

Assessments are due the first day of each month. Any installment of the annual assessment not paid to the Association within thirty (30) days after the due date shall be considered delinquent and a late charge of \$25.00 shall be assessed to the Owner and posted to the Owner's account every thirty (30) days delinquent.

Home Sales

Effective July 1, 1989, the Virginia General Assembly enacted a new law entitles the "Virginia Property Owner's Association Act". This act required the seller of a home to make certain disclosures to the intended purchaser of their lot. All home sales in Ashburn Farm are subject to the Virginia Property Owner's Association Act. A written request of the Association Disclosure Package and a check in the amount of: \$225.00 for an electronic disclosure (via email) for townhome/single family; \$250.00 for a paper disclosure for townhome/single family; \$100.00 for electronic or paper disclosure for condo; are required to begin processing. A rush fee of \$50.00 may be paid to receive your disclosure within 3 days. Checks should be made payable to the Ashburn Farm Association. A form is available on the website or at the Association office. The completed package will be issued within 14 calendar days to the requesting party or agent. For further information, please contact the Association office.

BOARD BRIEFS

A complete draft of the Board Meeting Minutes will be reviewed and approved at the next Board Meeting, which are held the first Tuesday of each month. A complete set of minutes is available on the Association's website, Board of Trustees page: https://ashburnfarmassociation.org/board-of-trustees/.

The following Meeting was held on February 1, 2022. President, David Tighe, called the meeting to order at 7:00 PM.

APPROVAL OF MINUTES

Motion to approve the January 4th Board meeting minutes as submitted, passed, (4/0/0/3), Mr. Han-cock, Mr. Oakley, and Dr. Lubore, absent.

BOARD MEMBER COMMENTS

Mr. Tighe– expressed his thanks to Mr. Hancock and Mr. Cushman for all their work over the last month reworking the process to improve the language for the 2022 Inspections.

Mr. Fedak – extended thanks to the Association staff team for their work on getting the newsletter on-time and on-schedule; he stated he likes the look, the sections and community info.

Mr. Batchelder – expressed that he is glad that Mr. Tighe is feeling better and back in charge.

PUBLIC FORUM -

No public comments were made.

MANAGER'S REPORT – reported by Mr. Cushman

Annual Inspection Notices, Process, Communication – the Board received email copies of Association Templates used to communicate with the membership from Mr. Hancock. There is much work to do to update the letters to be input in the Vantaca database before they can begin to be used. Mr. Cushman echoed support for the change in terminology from "Priority One, Two & Three" to "Issues, Concerns and Observations" and the mailing of a postcard to alert properties without a correction priority that their inspection report is available on the Vantaca portal.

Solar Panel Installation Update – still awaiting approval from Dominion Energy for the interconnection application. Once approved, the panel installations will take approximately 2 weeks total; there are no concerns with installation being complete before the pools open.

Swimming Pool Usage Rates – Mr. Cushman provided rate comparisons for other pools in the area and increased hourly costs with a recommendation to in-

crease the hourly rate to \$125. A motion to approve increasing the pool usage rate to \$125 per hour for the Windmill Pool, passed, (5/0/0/2). Mr. Hancock and Mr. Oakley, absent.

Dog Park Committee Draft Charter Review – Mr. Cushman stated the recent Townhome Survey responses included three requests for a dog park. The draft charter is for review, comment, and suggestions from the Board so that once the committee meets it can move forward.

Unique Neighborhood Standard – New Colony I & II – three homeowners were in attendance for this agenda item. Mr. Tighe clarified that this is in reference to the Architectural Review Board approving fencing that is prohibited by the Unique Neighborhood Standards as outlined in the Architectural Standards and that the committee has yet to recommend a change to the Unique Neighborhood Standard regarding fence style, material, and color.

Resource Path Lab Mobile Testing Site Request – The Association was contacted to consider allowing a trailer for providing Covid Testing for LCPS students and staff for symptomatic or exposure to Covid; they will also provide testing for travel. Breezyhill Pool parking lot was discussed as a convenient location. A **motion to approve the use of Breezyhill Pool parking lot space by Resource Path Lab until Memorial Day weekend, subject to approval by the Association attorney, passed, (5/0/0/2)**. Mr. Hancock and Mr. Oakley, absent.

Architectural Review Board Meeting Minutes – there was brief discussion regarding whether there are standards for solar installation applications. Action Item: Mr. Cushman to request the Architectural Review Board develop a Standard.

Budget & Finance Meeting Minutes, Bank Balances & Financials – Dr. Lubore gave a brief synopsis of the January meeting.

Townhome Neighborhood Committee – Mr. Butler, Chairman, provided an update on Committee activities, spoke about an upcoming Parking survey, and presented analysis of 5 key questions from the recent Trash survey. He presented a proposal that included a pilot program for a trash corral, education/friendly reminders through posters and mailers, volunteer involvement, and the possibility of changes to violation hearings. After Board discussion, a **motion for Ashburn Farm Association to spend up to \$2,000 for a pilot trash corral system in a townhome area TBA, for six months, passed, (5/0/0/2).** Mr. Hancock and Mr. Oakley, absent.

2022 Event Planning – Summer Kick Off Road Closure – Safety was a concern; the Board expressed that closing the street was their preference. There was discussion about rain date, food vendors, tailgating, and a possible beer/wine area. Other Community events will be discussed in upcoming meetings.

2022 Above-Ground Pool Consideration – kiddie and day pools will be allowed; enforcement of the ban on all other above-ground pools will resume. Notification via newsletter, email blast, and/or letters to those who had them in previous years.

Annual Meeting Date of Record – a motion to approve Resolution 02012022 regarding the Annual Meeting 2022 to be held on April 5, 2022, passed, (5/0/0/2). Mr. Hancock and Mr. Oakley, absent.

NEW BUSINESS

Ashburn Farm Association Mobile App – Digital Pool Pass & Amenity Reservation Service -

Mr. Cushman provided an update on the progress, capability for integration with website and Vantaca, ease of use and overall impact/efficiency this app brings to the organization.

Directors & Officers Insurance Policy Renewal – Mr. Cushman provided an update to the Board of an information request that put this item on hold until finalized. **Item Tabled**.

Townhome Committee Charter Approval – a motion to approve the Townhome Committee Charter, passed, (5/0/0/2). Mr. Hancock and Mr. Oakley, absent.

Luis Rosado Tennis Academy Court Rental Agreement – a motion to approve the continuation of the agreement between Ashburn Farm Association and Luis Rosado Tennis Academy, passed, (5/0/0/2). Mr. Hancock and Mr. Oakley, absent.

INFORMATIONAL

Association Delinquent Status Report – There was nothing to report.

Motion to enter Executive Session to discuss probable litigation, passed, (5/0/0/2); 8:41PM.

The Board exited Executive Session and resumed regular session at **8:57PM**.

A motion to begin administrative foreclosure proceedings against 21024 Timber Ridge Terrace #104, passed, (5/0/0/2). Mr. Hancock and Mr. Oakley, absent.

The Board of Trustees directed the Architectural Review Board that before approving another nonconforming fence, to consider and recommend a Unique Neighborhood Standard.

ADJOURNMENT

Motion to adjourn, passed, (5/0/0/2). Adjourned at 8:59PM.

During February and March we are often preoccupied with clearing driveways of snow, skiing the slopes or sipping hot cocoa by a roaring fire trying to thaw out from the winter chill. All too soon, warmer days will be upon us and we will be searching frantically for our pool pass so we can spend hours relaxing next to the cool, crystal clear water.

Did you know that the Association office processes new and updated pool passes throughout the year? To process new pool passes, an application, pictures and proof of residency to start the process can be emailed to pools@ afhoa.net or you may stop by the office between the processing hours of 10:00 am to 4:00 pm. If you are not sure if you are due for an updated pass, send an email to pools@afhoa.net, and we will check. Keep in mind that pool passes for adults are updated every five years, and children (up to the age of 21) are updated every three years. Passes should be issued for the first time at the age of two. Also, at the age of 9, children are required to have a picture on their pass.

If you are a tenant, a current lease and homeowner Offsite Information Contact Form are required to obtain your passes. The form is accessible on our website at www.ashburnfarmassociation.org, or you can submit a request for a copy to: pools@afhoa.net. The expiration dates for tenant passes will coincide with the end date on the lease.

March 18th, April 15th, May 20th, June 17th, July 15th, August 19th, September 16th, October 21st, November 18th, and December 16th.



2022 Annual Inspections



The Association is in the

process of planning for the 2022 "off property" annual inspections. As in the past, the Association will inform the community with a list of upcoming streets for inspection via the Association website, email blast notification each week, and will post signs indicating those streets to be inspected.

Inspectors will be utilizing public access (streets and sidewalks), rights of way, and Association Common Areas to inspect properties. The inspections will include taking photographs from off the property and making notes about any issues, concerns, or observations. An Inspection Report will be created and will note the observed conditions of the property, and any photos that were taken.

Unless Issues are observed, Members will be notified once a copy of your Inspection Report is available. Properties with Issues will be notified via letter and will include all issues, concerns and observations on the property and a timeframe to correct issues noted to enforce Association standards. Findings noted during the Off-Property Annual Inspection are limited to views available from public access (streets and sidewalks), rights of way, and Association Common Areas. These findings may not reflect the results of a resale disclosure inspection, which is an On-Property inspection. Resale disclosure inspections are required for all properties being sold in Ashburn Farm.

The Association will perform an On-Property inspection upon request and will reflect a resale disclosure inspection to notify you of any additional issues if you are considering selling your home.


